Minimum Purchase Payment

After the guaranteed interest rate period, the interest rate can be reset annually but will not be lower than 1.00%.¹

Additional First Year Interest (added to base rate)

+0.50% for the first contract year

Guaranteed Return of Purchase Payments

If selected at the time of purchase, Symetra guarantees that you never receive less than you contributed to your annuity, minus any withdrawals.

Guaranteed Lifetime Income Option

Anytime after the first contract year and before your 101st birthday, you can convert your annuity's accumulated value to a lifetime income stream.²

Nursing Home and Hospitalization Waiver³

Surrender charges are waived after 30 days of confinement in a nursing home or hospital, and up to 60 days after release. If you are confined to a hospital or nursing home on the contract date, you are not eligible for this waiver of surrender charges until after the first contract year.

10% Free Withdrawals

Withdrawals up to 10% of the contract value per contract year are free of surrender charges. Amounts in excess of 10% are subject to a charge based on the following schedule:
