Instructions and Definitions

This form must be completed and submitted with all applicants that are solicited and signed in a state other than the state in which the Applicant/Owner/Insured has established as their primary connection (or Nexus) to the United States.

In order to be an eligible client, the Foreign National Applicant / Owner / Insured must establish a connection (or Nexus) to the United States as is indicated in the Foreign National Program Guidelines and Sales, Solicitation and Service Agreement.

As a general rule, insurance products should not be solicited outside the state where the foreign national applicant has established their connection or nexus to the United States.

However, in some cases, it may be permissible for a proposed applicant/ owner / insured to complete and sign an application for Symetra Life Insurance Company (Symetra) products in a state other than the state where the Foreign National has established their primary nexus or connection to the United States. Such transactions may be proper when the proposed applicant/ owner / insured has some connection other than only the purchase of life insurance that brings the them to the non-nexus state where the application was completed.

- "Application state" is the state where the proposed applicant/ owner / insured signs the application and where the policy has been solicited and, if applicable, delivered. The application state must be a state where the agent/producer is appointed and licensed and the insurance product is approved.
- "Nexus state" is the state where the proposed applicant/ owner / insured has established a primary connection to the United States in order to be an eligible client.

Because Symetra's current procedure is to issue policies based on the application state, if the proposed owner has no valid connection with the state of application signing, the agent must resolicit the sale in the state where the Foreign National Applicant / Owner / Insured has developed their nexus connection to the United States.
